NatureClad Cellular PVC-UE and PVC-U Profiles and PVC-U Fittings-

15 Year Guarantee

1. Products covered by this Guarantee

- (a) This Guarantee applies to NatureClad Cellular PVC-UE and PVC-U profiles and PVC-U fittings (Chiminea Charcoal, Cumulus Grey, Morning Dew Silver, Coastal Sand, Rich Espresso.) manufactured by Kestrel. All other foiled profiles and fittings are excluded from this Guarantee.
- (b) This Guarantee applies only to building and construction applications (i.e. roofline, cladding and window trim). All other applications (including mobile homes) are excluded from this
- (c) This Guarantee applies only to products sold and fitted within the UK and the Republic of Ireland. Any products purchased or fitted in another jurisdiction are excluded from this Guarantee.
- Products which are not covered by this Guarantee may be subject to a separate guarantee.

2. Duration of this Guarantee

This Guarantee will remain in force for 15 years from the date of installation of the products.

3. Cover provided under this Guarantee

- (a) Kestrel guarantees that, for the duration of this Guarantee, but subject to the other provisions of this Guarantee
 - the profiles and fittings will not warp or crack
 - exposure to normal weathering will not result in any significant part of the woodgrain foiled profiles or fittings changing colour compared to Kestrel's relevant colour specification by more than grey scale 3 (where grey scale is determined in accordance with ISO105-A02). This paragraph 3(a) (ii) does not cover any change resulting from any form of shading (such as any overhang or any obstruction of the sun by any permanent or temporary structure or trees);
 - (iii) exposure to normal weathering will not result in any shrinking or delamination of the woodgrain foil from the profile to which it is adhered.
- (b) In the case of a valid claim under this Guarantee, Kestrel will, at its absolute discretion, either repair or replace the defective profiles and fittings. This Guarantee does not cover any labour costs incurred by the Customer or any third party in installing the repaired or replacement profiles and fittings.

4. Exclusions

(a) This Guarantee will not apply if:

- (i) the profiles or fittings have not been stored, installed and maintained in accordance with Kestrel's recommended fixing details and maintenance procedures
- the profiles and fittings have not been used in accordance with Kestrel's instructions, including, in the case of PVC-U Hollow Soffit profiles, if they have not been used as soffit;
- (iii) the profiles or fittings have been coated or had any other process or repair performed on them other than by Kestrel;
- (iv) the defect is caused by wilful or accidental damage, vandalism or negligence (other than that of Kestrel or its sub-contractors);
- (v) the profiles and fittings have been stored and/or permanently installed
- in climate zones where the ambient temperature regularly falls outside the range +40°C to -10°C, or
- (ii) at elevations above 1800 metres above sea level;
- (vi) the profiles and fittings have been exposed, in storage or end-use, to atmospheric pollution, acid rain, harmful chemicals or vapours, fire, lightning, flood, abnormal winds or earthquake, or the effects of external heat sources or reflective surfaces, or undue wear and tear, or other unusual conditions: or
- (vii) the profiles or fittings have been moved from the site where the defect is alleged to have occurred.

5. Transfer of this Guarantee & How to Make a Claim

- (a) This Guarantee is for the benefit of the Customer and only applies if proof of purchase can be provided. Proof of purchase must detail the relevant property address.
- Any unexpired part of the life of this Guarantee may be transferred to subsequent owners of the Property.
- This Guarantee along with the receipt shall be retained by the customer to demonstrate proof of purchase. Kestrel reserves the right to refuse any claim under a Guarantee where the customer cannot provide the original Guarantee document and
